Abstract: This paper provides a comprehensive analysis of the "centre of main interests" (COMI) within the framework of cross-border insolvency under European Union law. COMI serves as the central jurisdictional criterion for determining the competent court to open main insolvency proceedings and plays a pivotal role in ensuring legal certainty, creditor protection, and the effective coordination of transnational cases. The paper explores the origin and evolution of the concept, doctrinal interpretations, and relevant jurisprudence of the Court of Justice of the European Union (CJEU). Special emphasis is placed on the challenges arising from the artificial relocation of COMI by debtors seeking a more favourable legal environment—commonly referred to as forum shopping. The analysis highlights both the risks and legal constraints associated with such relocations and presents proposals for legislative reform aimed at enhancing transparency and consistency.

## Mihaela LAZOVIĆ, Aleksandar LAZOVIĆ - PSYCHOLINGUISTIC MOTIVATIONS FOR ANGLICISM USE IN TOURISM AND HOSPITALITY COMMUNICATION

Abstract: This paper explores the psycholinguistic motivations and implications behind the widespread use of anglicisms in the hospitality and tourism industry, with a particular focus on marketing professionals, influencers, bloggers, and trend promoters. Drawing from interdisciplinary frameworks in psycholinguistics, sociolinguistics, and discourse studies, the analysis reveals that anglicisms function as powerful cognitive and emotional triggers. These lexical choices are not merely linguistic borrowings but carry strong symbolic capital, aligning brands and individuals with perceived global values such as modernity, sophistication, innovation, and exclusivity. The paper argues that anglicisms enhance communicative efficiency in digital and multicultural contexts. Simultaneously, their use is driven by deep-seated psychological needs related to self-presentation, identity shaping, and social belonging, particularly within the performative spaces of social media and experiential marketing. However, the prevalence of anglicisms raises concerns about language authenticity and the loss of local identities. The study emphasizes the need for linguistic balance and greater awareness in language education within the industry. It also suggests future research on cross-cultural comparisons and consumer perceptions in the evolving digital hospitality landscape.

#### Tiberiu MEDEANU - Illegal clauses and penalties established when granting loans

Credit agreements, particularly those between consumers and non-bank financial institutions, have been marked by abusive clauses in recent years. At both national and European levels, a number of normative acts were put in place to control them. Legislation at the national level includes Law No. 193/2000, which prohibits unfair terms in contracts between traders and consumers, and Law No. 243/2024, which protects consumers from the total cost of lending and the assignment of receivables. If abusive clauses are invoked, then the Court of Justice of the European Union will uphold C-75/2019 which allows for an appeal for enforcement to be submitted despite the 15-day legal period. These regulations are aimed to give consumers more protection by restricting penalties, regulating the conditions for credit transfers, and enabling the challenge of unfair terms and illegal enforcement in court.

# Silvia Laura PASCU, Tania PETCOVICI - ENHANCING LANGUAGE ACQUISITION: EVALUATING THE EFFECTIVENESS OF MODERN AND TRADITIONAL METHODOLOGIES

Abstract: The current paper aims to describe the impact of modern teaching methods on the outcomes of English language acquisition in contrast to those derived from traditional methodologies. A number of 60 first-year university students, enrolled in a bi-weekly English as a Second Language course, has been divided into two groups. The initial group has undergone a full year's instruction in English utilizing modern methods (including Communicative Language Teaching, Task-Based Learning, and technology-enhanced pedagogies), whereas the subsequent group was subjected to traditional methodologies (specifically the Grammar-Translation Method and Audiolingualism). Employing a mixed-methods approach, the research studies quantitative data obtained from language proficiency evaluations alongside qualitative insights gathered from student interviews. The results reveal that contemporary methods improve learners' communicative skills and intrinsic motivation. Nonetheless, traditional approaches play a significant role in establishing foundational grammatical knowledge. The research concludes that integrating aspects of both traditional and contemporary methodologies, may be the most efficient approach for a diverse array of learners.

## Roxana Elena POPSA - HOTEL DIGITAL TRANSFORMATION: THE ROLE OF ARTIFICIAL INTELLIGENCE

Abstract: In the context of an increasingly digitalized environment, the integration of artificial intelligence (AI) within the hotel industry has evolved from a strategic advantage to a fundamental requirement for long-term success. Ongoing advancements in AI are redefining hotel operations by delivering innovative solutions aimed at streamlining processes, enhancing service personalization, and optimizing resource management. Thus, the paper aims to analyze how artificial intelligence is transforming the hotel industry, focusing on: the use of artificial intelligence in hotels' booking engines or websites; the most innovative services for hotel chains; the interest in AI chatbots among European accommodation businesses, while also presenting the hoteliers' opinions on the impact of AI on hospitality.

## Dušan RAJČEVIĆ, Hadžib SALKIĆ - CYBER THREATS: STATISTICAL INSIGHTS INTO MOBILE AND COMPUTER NETWORK SECURITY

Abstract: Cyber-attacks pose a significant threat to information security and network infrastructure, particularly in mobile devices and computer systems. This paper analyzes the five most common types of cyber-attacks – malware, DoS/DDoS, Man-in-the-Middle, phishing, and exploits using statistical methods. It examines attack frequency, interrelationships, and similarities between mobile and computer systems. Applied methods include regression analysis, correlation analysis, the elbow method for cluster determination, and K-means cluster analysis. The results indicate no significant correlation in the distribution of attacks across different platforms, while cluster analysis identifies two main attack groups. These insights are crucial for developing effective security strategies.

## Hadžib SALKIĆ, Nedžad KORAJLIĆ, Dušan RAJČEVIĆ - MODERN APPROACHES TO PROTECTIVE MEASURES IN CORPORATE SECURITY

Abstract: In the era of digital transformation, data security has emerged as a paramount challenge for corporations worldwide, particularly in the context of increasingly sophisticated cyberattacks. This study examines the efficacy of security measures within corporate environments, with a focus on mitigating prevalent cyber-attacks such as phishing, malware infection, distributed denial-of-service (DDoS) attacks, ransomware and SQL injection. By analyzing empirical data from 50 enterprises in Bosnia and Herzegovina, the research evaluates three critical dimensions, the extent of security protocol implementation, the risk-reduction impact of adopting ISO/IEC 27001 compliance, and the comparative effectiveness of paid versus free security software in safeguarding business infrastructure. Utilizing Pearson, Spearman and Kendall correlation analyses, the findings reveal that organizations employing integrated measures (firewall, encryption, regular audits) and paid tools such as endpoint protection, exhibit a statistically significantly reduction in successful cyber-attacks compared tothose that rely on free or built-in security features of operating systems. The study highlights the necessity of hybrid frameworks that integrate advanced technological solutions, adherence to international standards and ongoing staff training. The study contributes a novel regional perspective, addressing the unique challenges of cyber security faced by organizations in resource-limited

# Mirela TĂRĂBÎC - THE REORGANIZATION OF JUSTICE BY THE COMMUNIST REGIME ACCORDING TO THE CONSTITUTION OF THE ROMANIAN PEOPLE'S REPUBLIC OF 1948 AND ITS CONSEQUENCES ON ROMANIAN SOCIETY

Abstract: The Constitution of the Romanian People's Republic of 1948 represented the instrument by which the Romanian Workers' Party prepared the transition of the entire economy under state control. The constitution, being the fundamental law of the state, imposed the principle of popular sovereignty instead of national sovereignty, a fact that allowed the U.S.S.R. to intervene in the political and economic life of Romania. The Romanian state was organized on the principle of the unity of powers, and the leading role was held by the Romanian Workers' Party. The economic provisions prevailed over the political ones, the Constitution being the instrument, apparently legal, through which private property was abolished and the transition of the entire economy and private institutions under state control was being prepared, i.e.: banks, enterprises, means of production, internal and external trade, etc. Starting from 1948, the judiciary in Romania became an instrument to keep under control the population of Romania, condemned to live in a regime totalitarian communist.

## Mirela TĂRĂBÎC - CULTURAL LIFE IN BANAT AND COMMUNIST CENSORSHIP ANALYZED FROM THE PERSPECTIVE OF ORAL HISTORY

Abstract: Beginning in 1948, Romanian society underwent profound transformations modelled after the Soviet system, which significantly impacted the country's political, economic, legal, cultural, and religious spheres. These changes included the abolition of private property and its replacement by state ownership, the suppression of political pluralism and freedom of association, the establishment of a one-party dictatorship, the dismantling of civil society and indigenous structures, and the decimation of the interwar elites—cultural, political, administrative, and otherwise. The reorganization of cultural life at the national level was carried out under the strict supervision of communist authorities and in alignment with their ideological objectives. Consequently, only a few cultural institutions from the interwar period were able to continue their activity post-1948, while others were dissolved for promoting 'bourgeois mentalities' and replaced by institutions that endorsed communist ideology. Moreover, both nationally and regionally—in Banat—communist authorities actively targeted the Romanian intellectual elite from the interwar period, especially those opposing the Marxist-Leninist totalitarian ideology. For any community, recovering its past is essential, as national identity is built around a collective memory that must be preserved and cultivated. The interviews conducted with two prominent figures in the cultural life of Banat—Professor Deliu Petroiu and Professor Damian Vulpe—provide vital testimonies about cultural and artistic life in Banat during the communist regime. These oral accounts complement written documentary and narrative sources. Engaging with individual or collective memory is particularly important given that the historical discourse during the communist dictatorship was significantly distorted. For this reason, the recovery of memory forms a foundational aspect of oral history. Historiography in various capitalist countries shows a marked interest in oral history, recognizing it as a crucial means of recovering the past—especially in nations where totalitarian regimes have falsified history and collective memory. Prominent historians such as M. Finley, P. Chaunu, E. Renan, and H. Bergson have emphasized memory as a tool for recording, systematizing, analyzing, and reconstructing past events. Whether individual or collective, memory must serve justice—it should not be imprisoned by the past but should instead be harnessed in the service of the present and future, without inciting hatred or revenge.

Furthermore, techniques such as mindful breathing and mindfulness meditation contribute to immediate alleviation of stress and support emotional regulation. Even moderate and consistent engagement in physical activity can result in considerable mental health advantages, underscoring the imperative to incorporate exercise into daily routines for psychological equilibrium and resilience in the face of life's adversities.
